This does not waive rights of suit in the event that an action is termed criminal within the jurisdiction of applicable law.
2. Agree to indemnify and hold harmless the S.O.S., its officials and members for any loss, liability, damage or cost which may incur due to my presence at a S.O.S. event, whether I am competing, officiating or observing a S.O.S. event.
3. Assume the risks inherent in automobile racing and assume responsibility for the bodily injury or property damage which those risks can cause.
4. Agree to follow all the rules and regulations and responsibilities as printed in the 2023 S.O.S. rules. I hereby release the officials of the S.O.S. from damages resulting from their decisions and/or interpretations of rules.
5. Reserve to the S.O.S. and its members and officials, any rights to publish, produce, copyright, duplicate, reproduce upon hats, tee shirts, and other such novelty concession items, written articles about me, photos and drawings of my likeness or of my race car. This does not prohibit me from producing promotional products, nor does this allow the S.O.S. to take any proceeds from material produced by me, unless marketed by the S.O.S.
